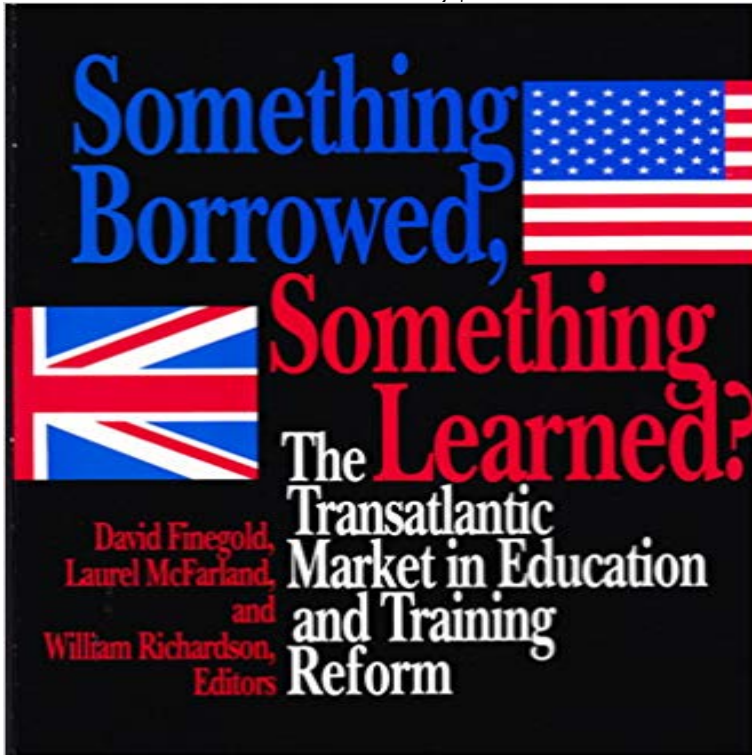


Something Borrowed, Something Learned?: The Transatlantic Market in Education and Training Reform
